NOW, THEREFORE, BE IT RESOLVED, that the Supervisor of the Town of Mexico is authorized on behalf of the Town Board of the Town of Mexico to increase the Boring Budget amount from \$3,252 current boring budget to a new total amount for project boring costs of #3,301, which is a \$49 increase; due to actual cost incurred, (copies of which are to be filed with the Town Clerk), for the Water Service Area #3.
