Supervisor Behling opened the regular Town Board meeting at 7:20pm with the Pledge of Allegiance.

Public Comment

Jeff Beardslee would like to donate placards for the Community Park, explaining the individuals after which each field is named.

Concerns were: The lawsuit with Oswego County regarding snow removal and what the settlement entails. Marsden said a committee has been formed among neighboring towns and a meeting will take place soon. Behling said the town is working with the county on other matters as well. Marsden said we maintain 66 miles of town and there are 12.15 miles of county roads in the town.

Reports

Town Clerk- A motion was made by Councilor Greenway and seconded by Councilor Robert to accept the April report as presented. The motion was adopted by a vote of 5 ayes: Behling, Barber, Greenway, Partrick, Robert, and 0 nays.

Dog Control- A motion was made by Councilor Greenway and seconded by Supervisor Behling to accept the April report as presented. The motion was adopted by a vote of 5 ayes: Behling, Barber, Greenway, Partrick, Robert, and 0 nays.

Zoning Officer/Building Inspector- A motion was made by Councilor Robert and seconded by Councilor Partrick to accept the April report as presented. The motion was adopted by a vote of 5 ayes: Behling, Barber, Greenway, Partrick, Robert, and 0 nays. Greenway asked if Marsden is switching over to square footage for determining permit fees, as opposed to estimated cost of the project. Marsden is moving forward as per the board's decision. Councilor Partrick asked for a recommendation at the June meeting.

Highway Superintendent- A motion was made by Councilor Patrick and seconded by Supervisor Behling to accept the April report as presented. The motion was adopted by a vote of 5 ayes: Behling, Barber, Greenway, Partrick, Robert, and 0 nays.

Parks Manager- Diehl said soccer and little league are using the park. The dugouts are complete but ruts left from work need to be fixed. Broken pipes have been fixed; the drainage is installed and cleanup is in progress; playground drainage is in progress. Diehl thanked the Village DPW for removing chips from the old playground since the Town equipment was too large for the area. Partrick asked if the contractors have been paid in fill. Diehl will inform the board when the work is complete. A motion was made by Councilor Greenway and seconded by Supervisor Behling to accept the April report as presented. The motion was adopted by a vote of 5 ayes: Behling, Barber, Greenway, Partrick, Robert, and 0 nays.

Mexico Point Park- Chepko-Sade said beach cleanup was a success and discussed I Love My Park Day. The CNY Arts grant was not awarded to the park, which means the Celebration of the Arts is cancelled. However, the fireworks and concert are moving ahead as planned. Bond said a foot wash station would help keep sand out of the sinks in the bathhouse; a new flag is needed; a utility cart would be helpful for clean-up; a disabled parking sign is missing; the caretaker cottage riser for septic tank needs fill. Partrick said he will call about filling the riser

space with topsoil. Bond said a memorial bench owner would like to install a cement slab under the bench. A motion was made by Councilor Partrick and seconded by Councilor Greenway to accept the April report as presented. The motion was adopted by a vote of 5 ayes: Behling, Barber, Greenway, Partrick, Robert, and 0 nays.

Planning Board- Weber said board members completed their annual training provided through the Tug Hill Commission. A motion was made by Councilor Robert and seconded by Councilor Partrick to accept the April report as presented. The motion was adopted by a vote of 5 ayes: Behling, Barber, Greenway, Partrick, Robert, and 0 nays.

Zoning Board of Appeals- Waterbury said the only new item is an application for a bait and sporting goods shop near the intersection of St. Rt. 3 and St. Rt. 104B. A motion was made by Councilor Greenway and seconded by Supervisor Behling to accept the April report as presented. Barber said the striker has been modified since December.

WHEREAS, the Town Board has been asked to consider the formation of a water service area in the Town of Mexico to be known as the Town of Mexico Water Service Area No. 6, pursuant to Article 12-C of the Town Law of the State of New York; and

WHEREAS, a Map, Plan and Report prepared by C2AE, Consulting Engineers of 70 Main Street, Canton, New York 13617, pursuant to Article 12 of the Town Law of the State of New York was filed with the Town Clerk for the Town of Mexico the 11th day of January, 2021, and entitled Town of Mexico Water Service Area No. 6; and

WHEREAS, the notice of the public hearing was published in the official newspaper of the Town, Oswego County News, and posted on the town bulletin board pursuant to Section 209q of the Town Law of the State of New York; and

WHEREAS, said public hearing having been held May 9, 2022, at 7:00 p.m., after notice with all interested parties having been heard on the proposed district; and

WHEREAS, the Town Board at a meeting on May 9, 2022 had a full discussion pertaining to the proposed Town of Mexico Water Service Area No. 6, has heard the public comments and has discussed same with consulting engineers, C2AE, as well as the attorney for the Town, Graham B. Seiter, Esq.

WHEREAS, the boundaries of the proposed Water Service Area No. 6 were previously omitted from the publication dated January 20, 2021, and the Resolution/Order for Public Hearing on the establishment of the Town of Mexico Water Service Area No. 6 was re-published in the Oswego County News on April 22, 2022, and are as follows:

WHEREAS, the proposed budget apportioning of the funds for Water Service Area No. 6 were previously omitted from the publication dated January 20, 2021, and are as follows: ADMINISTRATIVE – Legal \$25,000, Bonding \$15,000, Net Interest \$80,000, Bookkeeping and Reporting \$5,000, Single Audits \$15,000; TECHNICAL SERVICES – Preliminary Engineering Services \$23,200, Design Phase \$407,320, Contract Administration \$150,000, Resident Inspection \$120,000, Additional Engineering Services \$70,000, Surveys \$62,500, Borings \$7,500; CONSTRUCTION \$4,004,000; CONTINGENCY \$480,480;

NOW, THEREFORE, it is hereby resolved as follows:

- That the notice of public hearing was published and posted as required by law and
 is otherwise sufficient;
- That all of the property and property owners within the proposed water service area are benefitted thereby;
- That all of the property and property owners benefitted are included within the limits of the proposed water service area;
 - That the formation of the proposed water service area is in the public interest;
- The boundaries of Water Service Area No. 6 are as follows: See attached Schedule A;

- The maximum amount proposed to be expended for such improvements is FIVE MILLION FOUR HUNDRED SIXTY-FIVE THOUSAND DOLLARS (\$5,465,000.00); and
- 7. The estimated annual cost to the typical property/typical home or equivalent dwelling unit ("EDU") would be \$903.00, said amount includes the typical annual water use costs estimated at 170 gallons per day; and said annual cost would be assessed solely against properties in the proposed water service area on a benefit basis according to the established "EDU" criteria; and
- 8. The improvements proposed, to be a new water distribution system to include meter pits, remote read meters, service lines to the curb box. Fire hydrants will also be installed as part of the project. All property owners who connect to the water main will be required to disconnect their private supply. The estimated cost for a property owner to install a service line from the curb box to the user's residence is \$800-\$1,200 and there is no hookup fee charged by the Town; and
- 9. The proposed budget apportioning of the funds are as follows: ADMINISTRATIVE – Legal \$25,000, Bonding \$15,000, Net Interest \$80,000, Bookkeeping and Reporting \$5,000, Single Audits \$15,000; TECHNICAL SERVICES – Preliminary Engineering Services \$23,200, Design Phase \$407,320, Contract Administration \$150,000, Resident Inspection \$120,000, Additional Engineering Services \$70,000, Surveys \$62,500, Borings \$7,500; CONSTRUCTION \$4,004,000; CONTINGENCY \$480,480; and
- 10. That based upon 1-9 above, this Board does hereby re-approve the formation and establishment of the water service area to be known as the Town of Mexico Water Service Area No. 6 pursuant to the terms and boundaries as found in the Map, Plan and Report prepared by C2AE, Consulting Engineers, and filed with the Town Clerk the 11th day of January, 2021.

Resolution 2022-48 Local Law 4 of 2022: Commercial Sawmill Regulations

Councilor Partrick asked Seiter to make the law clarify commercial sawmills in section 4, item 1. Councilor Greenway expressed concern that the regulation on sawdust and waste referenced in section 4, item 6 cannot be enforced. Seiter will strike the 3-month timeline on waste removal. Councilor Robert asked who will check log restraints. Seiter said applicants will need certification from an engineer. Seiter said special use permits are not transferrable regardless of the type of use.

WHEREAS, the Town Board has considered adopting Local Law 4 of 2022 a local law to amend Local Law No. 5 of 2003, amending the Town's Zoning Law in regard to the regulations of commercial sawmills within the Town of Mexico; and

WHEREAS, the Town Board has reviewed the proposed local law, held a public hearing regarding same, after notice, on the 9th day of May, 2022, at which time members of the public had the opportunity to speak and comments were received regarding the local law; and

WHEREAS, after full discussion, the Town Board deems it in the best interest of the Town to adopt the proposed local law; and NOW, THEREFORE, on motion made by Councilperson Partick seconded by Councilperson Behling, be it resolved as follows:

- That Local Law No. 4 of the Year 2022, a Local Law to amend Local Law No. 5 of 2003, amending the Town's Zoning Law in regard to the regulations of commercial sawmills within the Town of Mexico, is hereby adopted by the Town Board.
- That Local Law No. 4 of the Year 2022 shall take effect upon filing with the New York State Secretary of State.
