The OCO Nutrition Services Meals on Wheels Program is in need of a volunteer driver to deliver meals on Mondays.

Some information facts on the volunteer route is the volunteer would be delivering Monday's and Tuesday's meals when they deliver on Monday.

The route is roughly 13 miles round trip while the meals can be picked up between the times of 9:30-10:30 on Mondays. There are 11 clients so once volunteer is comfortable with the delivery process it will take them roughly 45 – 60 minutes to complete all the deliveries.

Mileage reimbursement can be requested on a monthly basis and many of the holidays that the program is closed on falls on ....Mondays.

The volunteer route can be done as a group with group members alternating Mondays so it does not fall all on one person.

### Historian Report for November 2025

1. Storm doors for the Museum have been ordered and are expected to arrive soon. The old doors have already been removed.
2. The Museum will be open to the public for the Christmas in Mexico event on December 6. After this, it will remain closed until spring. Sandy Burdick will oversee the opening of the Museum for the holiday event and will also manage the preparations necessary for its winter shutdown. Following the event, the water at the Museum can be turned off until reopening in the spring.
3. Efforts are ongoing to scan photos, documents, and newspaper clippings from both the Museum and the historian's office. This process helps preserve historical materials and make them more accessible.
4. Several inquiries from the public have been addressed during this period, demonstrating continued interest in the history of the Town of Mexico.
5. The Historian will be out of town until early April but will continue working remotely on home histories and other posts for Facebook. Additionally, work will proceed on content for the Town website. The scanned items will be organized and posted in a gallery format for the public to view and enjoy.
6. I will also be available by email or text/phone if any problems or questions arise.

This Local law Shall be known as Local Law No. 1 of 2026, a local law changing the date established for Grievance Day for Real Property Assessment Review.

## SECTION 2: AUTHORITY

This Local Law is enacted pursuant to Real Property Tax Law Section 512, which establishes Grievance Day as the fourth Tuesday of May, but enables a Town to change such Grievance Day by Local Law.

## SECTION 3: STATEMENT OF PURPOSE

The Town of Mexico employs a sole Assessor who also serves as the Assessor for other assessing units. Pursuant to the authority granted in Real Property Tax Law, Section 512, the Town of Mexico wishes to establish a date for the meeting of the Board of Assessment Review to hear grievances other than that established in Real Property Tax Law, Section 512, subsection 1.

## SECTION 4: GRIEVANCE DAY

The Town of Mexico hereby adopts as its Grievance Day the Thursday immediately following the fourth Tuesday of the month of May and so many days thereafter as the Board of Assessment Review deems necessary for the purpose of the Board of Assessment Review hearing complaints in relation to assessments.

## SECTION 5: SEVERABILITY

If an article, section, paragraph or provision of this Local Law shall be deemed invalid by any authority of competent jurisdiction, such determination shall apply only to the article, section, paragraph or provision adjudged invalid and the rest of this Local Law shall remain to be valid in full force and force and effect.

## SECTION 6: EFFECTIVE DATE

This Local Law shall take effect immediately upon filing with the Secretary of State.

This can be a resolution that the board votes on at their next meeting. As mentioned in our phone call, I will be heading out on maternity leave within the next couple weeks, so we will need to add another BCA representative to the application to ensure that it can be submitted on the Town's behalf. Could you provide another authorization letter like the one I attached that you completed for me previously but for Amanda Malmin in our office? I have copied her, along with Mike Altieri on this email.

Once you have completed the application process for the Level 2 eAuth ID and have been approved, you can get into the application and certify the necessary documents. Instructions for completing the application are attached.

The last step to this process is to publish a Notice of Intent to File resolution within 60 days of the application being submitted. We will let you know when the application is submitted and the 60-day clock starts. I have attached a template for this resolution that was provided by RD, which also includes instructions. The Affidavit of Publication can actually be sent to us, and we can pass it along to RD.
