Mayor Grimshaw called the regular meeting to order at 6:00 pm.

Trustee Emery wanted to thank the State DOT for meeting with the Mayor and the Trustees in regards to the best-case scenario for parking on Main Street in the business district.

Trustee Emery also wanted to thank Bob Oustrich for an outstanding job getting the village cemetery ready for Memorial Day weekend.

On motion of Trustee Emery, seconded Trustee Hotchkiss, all aye, the village board set the date of May 15th for all bodies to be removed from the vault in the Village Cemetery.

The Village Board tabled setting a date for a public hearing to amend the zoning law until they have adequate time to review the updates.

On motion of Trustee Hotchkiss, seconded Trustee Emery, all aye, the board agreed to the five annual payments for the 2021 International truck to begin July 1, 2022 in the amount of \$21,742.74 from Real Lease.

On motion of Trustee Emery, seconded Trustee Hotchkiss, all aye, the board agreed to use ARPA funds to purchase a Daktronics sign for the village park from Toth's Sports per quote in the amount of \$38,055.00.
