Christal Watters informed the board that she is in the process of purchasing the Beck's Hotel property. She requested a public hearing for a Restore NY grant that she is applying for. On motion of Trustee Hotchkiss, seconded Trustee Linerode, all aye, the board set the date of Wednesday, January 18, 2023 at 4:00 pm for Christal to present her plans for all interested parties.

Mike Lasell from MBL Engineers discussed the plan for Judd Porter's property that he purchased on Hamilton Street. On motion of Trustee Hotchkiss, seconded Trustee Harter, all aye, the board passed the following resolution:

Resolution that the Village of Mexico intends to take over the proposed infrastructure to support the construction of the residential subdivision off from Hamilton Street

WHEREAS, tax map number 134.07-01-01.13 owned by Justin Porter is proposed to create a 16-lot subdivision for Residential development

WHEREAS, the developer plans to install roadways, sanitary sewer, storm sewer and a water main throughout the park within the ROW & Easements which is intended to be taken over by the Village once installed with the following conditions:

- *The infrastructure will be installed meeting Village specifications and as approved by the Village Engineer
- *The projects infrastructure could be completed in phases in which portions of the project may be turned over once approved by the Village Engineer

WHEREAS, once construction is complete and infrastructure is inspected and accepted by the Village and Village Engineer the Village will assume ownership and maintenance duties.

NOW, THEREFORE, BE IT RESOLVED by the Village of Mexico's Board of Trustees that the proposed infrastructure is intended to be taken over by the Village of the above referenced Development.

Mike Mowry would like the board to reconsider the \$25.00 fee for final water readings. The mayor informed Mike that they will look into this is the future if the village has a different way to retrieve readings.
